Neighbor Spotlight

Rosemary Gardens Neighborly would like to highlight many of our long-time residents of the neighborhood, including our neighbors Ray and Mary Clymer. Ray and Mary have lived in the neighborhood twice!

Ray was born and raised in Oklahoma. His family moved to Hollister to begin a produce business that they operated from 1937 to 1947. Ray and Mary met in 1948, fell in love, and were married in 1949. Ray began working for Terminix after he and Mary married in 1949. Ray then worked in finance for Commercial Credit Corporation for 33 years. From Commercial Credit Corporation, Ray moved to Bank of Santa Clara, where he worked for 15 years. As many of you remember, Bank of Santa Clara later became Greater Bay Bank, which later became Wells Fargo Bank. Mary worked with the Santa Clara County School District from 1970 to 2014.

Nearby Redevelopment Application

You may have seen the Public Notice sign posted on 1249 N. 1st Street, the building located just past the 76 gas station (previously Lily Spa). This notice from the City of San Jose, which for some reason had been removed by the landowner for the past year, shows that the landowner has applied for permits to redevelop the property, which borders a number of homes on the 1200 block of Keoncrest. The permit application indicates the owner is seeking to demolish both 1249 and 1231 N. 1st Street (Bay Maples) structures and build an 8,616 square foot, one-story commercial retail center with 40 parking spaces. You can view project information by visiting sipermits.org, click on the purple Search for Permit box, then enter H17-002 in the Permit Reference Number section. We encourage residents to be informed and speak up before permits are approved. Questions and concerns can be directed to the Project Manager, Ms. Rina Shah, at 408-535-3555, or rina.shah@sanjoseca.gov. If the Planning Department receives enough interest or concerns about the project, they will hold a community
