Report Illegal Fireworks

I was asked to represent District 3 in an all district group that has focused on the issue of illegal fireworks for years. Recently, the illegal fireworks program has received some resources to help in enforcement and reporting.

I attended a special meeting with Rachel Roberts, Deputy Director of Code Enforcement, Captain Jason Ta, San Jose Police, San Jose Fire Captain and PIO, where they were kind enough to answer some questions we had about the recent changes in the ordinance and how we might inform our neighbors to report the use of illegal fireworks.

Regardless of the time of year, if you see or hear illegal fireworks being exploded near you, report it online. Visit sanjoseca.gov/fireworks to access San Jose's Illegal Fireworks Report form. Code Enforcement will analyze the data, together with San Jose Fire Department, and focus on hotspots to enhance covert enforcement efforts. San Jose Police is currently conducting covert operations targeting the sales of illegal fireworks in San Jose. San Jose Fire and Police expect to launch their own public service announcements highlighting their increased efforts to combat the use of illegal fireworks.

San Jose residents are encouraged to report the use of illegal fireworks in their neighborhoods. We believe that the increased covert operations, increased penalties, and the social host ordinance, will bring about significant changes in the coming years.

Shelter Housing & Rosemary Gardens

The RGNA board hosted a special board meeting with the Abode Services staff. They are the property manager for the 76-unit SureStay Hotel at 1488 North First Street.

They explained that their units offer supportive housing to members of the community that need assistance. They receive referrals for their shelter housing from Santa Clara County and City of San José. According to Abode there is no disqualification for referrals, and no eviction process for tenants because these units are considered shelters. The units provide housing for single individuals (no children on site).

They assured us that there is on-site security, and a property manager on site to coordinate services and work with neighbors. We asked about the unit next to this hotel (Airport Hotel, appears to be closed and fenced in) and they did not have any information about this property.

We asked about crime concerns at this property and they said they had not experienced any and would refer us to local law enforcement for crime prevention concerns.

Marguis and Danielle will be the managers on-site and they welcomed our overtures to help and assist in any way possible. Due to COVID restrictions, at this time, they do not expect to have outside visitors on the premises. RGNA will send an email to Danielle and ask her to keep us in mind for volunteer opportunities in the future.
